

### A Word from the Department Chairs

It is our pleasure to present the WU Department of Economics and provide a selected overview of its activities during 2021 in this brochure.



This report premiers the department's new look. The Department of Economics at WU currently employs 23 tenured faculty (professors and associate professors), 11 researchers (post-docs) on fixedterm contracts, and 4 (assistant professors) on tenure-track positions. Sixteen students are currently enrolled in our PhD Program in Economics, with three additional slots opening in 2022. Through a concerted effort and given our size, we are confident in our ability to further strengthen the department's visibility as an outstanding research institution, as is already reflected in rankings (e.g. best-ranked Austrian University according to the QS World University Rankings by Subject 2021: Economics & Econometrics) and the education of young scientists in a high-quality doctoral program.

In 2021, the department also participated in numerous ongoing initiatives at WU. These included a major effort to reform the "Wirtschafts- und Sozialwissenschaften" bachelor's degree program. The reform opens up more room for specializations and improves opportunities for combining complementary subjects, thus enhancing the flexibility of the curriculum. Students of economics will be able to choose from a wider range of interrelated fields, and the department will also offer newly designed courses as complementary subjects for students of business administration, law, and socioeconomics. The English-language Master's Program in Economics has also undergone some reforms. It now offers more elective options, including a new specialization in data science and machine learning.

These changes make our degree programs even more attractive and aim to strengthen our position as the largest academic training program in economics in Austria.

Other exciting events occurred in 2021 as well. Esther Arenas Arroyo was awarded the venia legendi (habilitation) and her contract was upgraded to a tenure-track position. The department hired Ana Abeliansky, Tingminke Lu, and Daniela Rroshi as post-doctoral researchers. Lukas Brunninger, Lydia Dimitrakopoulou, Oscar Fernandez, Francesco Scarazzato and Zhenyi Wang form the new PhD cohort this year. We warmly welcome our new colleagues. The department also said goodbye to some members. Alfred Stiassny retired this year. Among his many other



contributions to the department, he will be remembered by students primarily for his years of teaching and organizing the Principles in Economics course in WU's undergraduate program. We would like to thank him for his dedication and many years of exceptional service. Some of our PhD students have moved on, and Maximilian Böck is now at the Vienna School of International Studies, Simone Haeckl at the University of Stavanger Business School, and Gregor Zens at the Department of Decision Sciences at Bocconi University. We congratulate our junior researchers on their new positions and wish them all the best for their future careers.

Last but not least, Cécile Undreiner and Lena Zimmermann, very valued employees in the administration, left the department this year. For years, Cécile offered her expert support in organizing teaching activities, along with many more and varied department-wide tasks. Lena has been a tremendous support and has done incredible work in reorganizing the administrative processes in the department. We would like to take this opportunity to thank them both and wish them every success in their future careers.

2021 also presented some difficulties. Along with the burden of the ongoing pandemic, the reorganization required considerable time and effort. We are aware that we have asked a lot from all department members. We would like to take this opportunity to again express our gratitude to all who have contributed to everything achieved this year. 

### WU Researcher of the Month: Christoph Weiss

Christoph Weiss was awarded Researcher of the Month in March 2021. In his research, he has focused on the correlation of knowledge and information and price dispersion. Conducted with colleagues Dieter Pennersdorfer, Biliana Yontcheva and Daniela Rroshi, his study investigated the impact of information on prices in specific economic sectors, such as the gasoline and restaurant markets. The researchers found that being better informed was not only beneficial for individuals; it also exerted a positive effect on society as a whole by influencing the functioning of markets.

### WU Researcher of the Month: Ingrid Kubin

Ingrid Kubin was awarded Researcher of the Month in July 2021. Using a macroeconomic model, the researcher analyzed the role of optimistic and pessimistic expectations on lending decisions in the financial markets. She was able to demonstrate that swings between pessimistic and optimistic sentiment lead to stronger income fluctuations over the business cycle and thus show that the financial markets are influenced by behavioral aspects. The study's findings provide the basis for more applied research on how to design regulation schemes for financial markets to make economies more stable and resilient.

### 2021 Stephan Koren Prize for Simone Häckl-Schermer

Every year, the WU Vienna Full Professors' Association awards the Stephan Koren Prize to doctoral candidates who have made the largest contribution to maintaining the high reputation of WU dissertations with the academic community. In 2021, Simone Häckl-Schermer from the Department of Economics was awarded the prize for her dissertation on "Behavioral Motives to Work Hard: Three Essays Using Real-Effort Experiments".

## 2021 WU Lecture in Economics

WU matters. WU talks. Geoeconomics and Zero-Sum Logic (December 15, 2021) Inaugural lecture of Professor Gabriel Felbermayr

Gabriel Felbermayr (Professor of Economic Policy) discussed the consequences of geostrategic rivalries on international trade policy in the context of decelerating globalization.

Countries differ greatly with regard to their political and economic systems. Their goals and instruments have remained largely heterogeneous long after the ostensible end of the Cold War.

Geoeconomics is a subfield of economics that follows the trend of countries using economic instruments - especially instruments of foreign trade and exchange rates - to pursue power politics. Unlike classical foreign trade theory, which aims to increase welfare, such policies often follow a zero-sum logic, i.e. they seek to benefit one country at the cost of another. Gabriel Felbermayer is an expert in this field, and his work includes the empirical evaluation of the real GDP effects on countries from economic sanctions against Russia as well as from trade wars. In his presentation, he discussed how geostrategic rivalries emerge and what they imply for international trade policy. One inherhent element of zerosum logic is that it prevents cooperation because one country is attempting to weaken rather than strengthen another country.

As such, it hampers solutions to key global challenges such as climate change. Gabriel Felbermayr concluded his presentation with an outlook on current and possible future strategies to protect the EU's economic sovereignty and prosperity.

The event was held as the inaugural lecture for Gabriel Felbermayer who was appointed Director of the Austrian Institute of Economic Research (WIFO) and joined WU in a part-time position in October 2021. In his research, Gabriel Felbermayr focuses on international aspects of trade policy, migration, climate policy, development, and European integration. Vice-Rector for Infrastructure and Digitization Tatjana Oppitz opened the lecture on behalf of WU. Ingrid Kubin (Professor of International Economics) gave a welcoming speech in which she also provided a specialist outlook on the topic. Harald Oberhofer (Professor of Empirical Economics) chaired the panel discussion, which addressed further issues, such as the role of China and the debate around the distributional effects of trade.

### Webinar "The ECB's Monetary Policy Strategy Review"

### (March 22, 2021)

The COVID-19 pandemic has created enormous challenges for economic policy. It serves as an early stress test for the new monetary policy frameworks central banks are about to develop in the process of reviewing their strategies.

In this webinar, Athanasios Orphanides, professor at MIT Sloan School of Management and former member of the Governing Council of the European Central Bank, discussed the challenges of monetary policy in the (post-)pandemic world saddled with high debt and the possible effectiveness of current and future strategies on the recovery process.

The webinar was jointly organized by Aurel Schubert, former Director General Statistics, ECB and by the Department of Economics at WU Vienna.

### Webinar "The ECB's Monetary Policy Strategy Review - An Overview of the Issues"

#### (April 30, 2021)

Governments around the world have made vigorous use of fiscal policy to support domestic economies that are ailing due to the COVID-19 pandemic, thus pushing up public debt levels. Also, monetary policy has provided substantial stimulus to stem the crisis by rolling out new large-scale asset purchase programs mainly targeting government bonds. At the same time, several central banks have gone or are going through a monetary policy strategy review. The ECB resumed its strategy review last September after a pause imposed by the pandemic and now aims to finish it around September 2021. In this webinar, Frank Smet, professor at KU Leuven and Director General for Economics at the European Central Bank, discussed the very high levels of government debt and other economic fallout from the pandemic and their role as a first test for the future strategy.

### Webinar "Central Banks in Times of COVID-19"

#### (May 17, 2021)

In this webinar, Otmar Issing shared his insights and expertise on the role of central banks during the COVID-19 pandemic. He has been president of the Center for Financial Studies since 2006. From 1998 to 2006, he was a member of the executive board of the European Central Bank and responsible for economics and research, making him the chief economist and chief architect of the current ECB monetary policy strategy. This strategy is currently under review. Before his spell at the ECB, Professor Issing was a member of the board of Deutsche Bundesbank, a member of the German Council of Economic Experts and professor of economics at the University of Wuerzburg and at the University of Erlangen-Nuernberg.
