

## **VISITING SCHOLAR PROGRAM**

**Visiting Research Scholars, Visiting Senior Research Scholars Program and Senior Research Fellow Program at the Institute for Austrian and International Tax Law (WU):**

### **VISITING RESEARCH SCHOLARS:**

Each year, the Institute for Austrian and International Tax Law at WU selects outstanding doctoral students from other distinguished universities who wish to visit the Institute for periods of one month to one year as Visiting Research Scholars. Within the frame of the Visiting Research Scholars Program for Ph.D. students, current Ph.D. students, who are sufficiently proficient in their disciplines, are provided with the opportunity to visit the Institute for Austrian and International Tax Law to engage in scholarly interaction. The program is aimed at tax researchers interested in spending time contributing to the Institute's research projects (for a description of the Institute's current research projects see <https://www.wu.ac.at/en/taxlaw/research/project>). It is expected that the Scholar will divide his/her time between his/her personal research on topics which are of interest to the Institute and ongoing projects of the Institute on which research assistance may be needed. Research areas in which the Institute has particular interest are international tax law (including tax treaties) and European tax law. Applicants must be doctoral students who are near the end of their required coursework or in the dissertation phase. Any graduate degrees or extensive work experience is favorable.

Visiting Research Scholars are not charged any fees by the Institute if they are full time students at their home institutions and if they are not employed by any non-research institution. They must have health insurance and adequate financial support for the duration of their stay. Financial support can be from external sources, such as the student's home university or government, or from personal or family savings.

Visiting Research Scholars are provided with access to the Institute's library and to other research infrastructure of the Institute, the opportunity to sit in on selected advanced classes with the instructors' permission, and shared desk and computer space, if available. Visiting Research Scholars will also benefit from participation in a wide range of seminars and from interaction with a large group of fellow doctoral students. Visiting Research Scholars are not provided with housing or housing services. They are expected to participate in the Round Table Seminars and other specific events of the Institute. Visiting Research Scholars are invited to provide a research paper at one of the Institute's Round Table Seminar, if they wish to and if



there are free slots available. The topic of the research paper and the date of the discussion has to be agreed at the beginning of the research stay, the paper has to be distributed a week before the scheduled Round Table Seminar.

#### **SENIOR VISITING RESEARCH SCHOLARS:**

The Institute for Austrian and International Tax Law at WU selects outstanding postdoctoral researchers from other distinguished universities who wish to visit the Institute for periods from one month to one year as Senior Visiting Research Scholars. Within the frame of the Senior Visiting Research Scholars Program for postdoctoral researchers, it is intended to provide experienced researchers with the opportunity to visit the Institute for Austrian and International Tax Law to engage in scholarly interaction. It is expected that the Senior Visiting Research Scholar will spend his/her time for his/her personal research on topics which are also of interest to the Institute. Research areas in which the Institute has particular interest are international tax law (including tax treaties) and European tax law. Other areas may be agreed as well. They are invited to participate in the Round Tables and other specific events of the Institute.

Senior Visiting Research Scholars are not charged any fees by the Institute if they are full time researchers at their home institutions and if they are not employed by any non-research institution. They must have health insurance and adequate financial support for the duration of their stay. Financial support can be from external sources, such as the home university or government, or from personal or family savings.

Senior Visiting Research Scholars are provided with access to the Institute's library and to other research infrastructure of the Institute, and shared desk and computer space, if available. Visiting Senior Research Scholars will also benefit from participation in a wide range of seminars and from interaction with a large group of other researchers. Senior Visiting Research Scholars are not provided with housing or housing services. Senior Visiting Research Scholars are invited to provide a research paper at the Institute's Round Table Seminar, if they wish to and if there are time slots available. The topic of the research paper and the date of the discussion has to be agreed at the beginning of the research stay, the paper has to be distributed a week before the scheduled Round Table Seminar.

**SENIOR VISITING RESEARCH FELLOWS:**



Full Professors of other distinguished universities who wish to visit the Institute for periods from one month to one year may be appointed as Senior Visiting Research Fellows of the Institute for Austrian and International Tax Law. Senior Visiting Research Fellows are not charged any fees by the Institute. They must have health insurance and adequate financial support for the duration of their stay. Senior Research Fellows are not provided with housing or housing services. They will have preferred access to the research infrastructure of the Institute, which has to be agreed on an individual basis.

Applicants should apply at least 5 months prior to their intended visit to [denisse.vincke@wu.ac.at](mailto:denisse.vincke@wu.ac.at) . We ask for the following information/details:

- \* **Current resume and list of publications or link to a personal website providing these details.**
- \* **Brief statement describing the field of research and details or reasons for visit. This helps us to plan your research stay details individually.**
- \* **Requested research period (1st choice) and alternative date (if first choice is not available)**
