EUROPEAN ACADEMIC TAX THESIS AWARD



Dr. Mario Tenore, Member of the EURYI-ESF Research Team on “The Impact of European Law on the Relations with Third Countries in the Field of Direct Taxes” (Director: Prof. Dr. P. Pistone) at the Institute for Austrian and

International Tax Law (Director: Prof. Dr. M. Lang), has been awarded the **2009 European Academic Tax Thesis Award**.

The award is a joint venture of the European Commission (Directorate General Taxation and Customs Union) and of the European Association of Tax Law Professors (www.eatlp.org), an association which counts more than 400 tax law professors from European as well as from non-European countries. The thesis focused on taxation of cross-border dividends in Europe, based on a methodology that combines international tax with European tax law. It analyzes tax aspects related to the topic of dividends arising from the corporate-shareholders relations in all possible scenarios, involving individuals, companies, other entities. Cross-border scenarios are dealt within the European Internal Market, in the relations with third countries or just between/among non-European countries, ranging from tax legal theory to national, international law (including tax treaties), European Law (including primary and secondary law) and comparative tax law. The prize will be granted at the annual meeting of the European Tax Law Professors, which will be held on June 4th, 2009 in Santiago de Compostela (Spain). The winner will also be invited to report on his doctoral thesis to interested officials of the European Commission.
